Common renovation activities like sanding, cutting and demolition can create hazardous lead dust and chips by disturbing lead-based paint, which can be harmful to adults and children.

To protect against this risk, the Environmental Protection Agency (EPA) issued a rule in April 2008 requiring the use of lead-safe practices and other actions aimed at preventing lead poisoning.

Beginning in **April 2010**, under this rule, contractors performing renovation, repair and painting (RRP) projects that disturb lead-based paint in homes, child care facilities and schools built before 1978 **must be certified** and must follow specific work practices to prevent lead contamination.
